

MPW Water Rates

Facilities Charge:

This charge covers fixed costs that Muscatine Power and Water incurs to service each customer, regardless of usage. These costs include service facilities, meter reading, bill distribution, and payment processing.

Commodity Charge:

The commodity charge is the cost of the water supply that you use – it represents actual consumption.

Demand Charge:

A demand charge applies to Industrial I & II customers. The demand charge will be applied to the highest of: current month consumption, highest demand in preceding eleven months, or 75% of the highest monthly consumption occurring during the preceding 5 year (60 months) window. All adjusted to 30.4 day equivalent consumption.

Customers with monthly billing demand of 35,000 CCF to 500,000 CCF.

Monthly Rate:

Facilities Charge.....	\$1,383.72 per month
Demand Charge.....	\$0.1577 per CCF*
Commodity Charge.....	\$0.2253 per CCF

**Applied to higher of current month consumption, highest monthly consumption in preceding eleven (11) months, or 75% of the highest monthly consumption occurring during the preceding five (5) year (60 months) window. All as adjusted to a 30.4-day equivalent.*

Minimum Bill:

Facilities Charge plus Demand Charge

Industrial II Water effective April 1, 2021

Applies to:

Consumers with monthly billing demand greater than 500,000 CCF.

Monthly Rate:

Facilities Charge.....\$1,554.99 per month
Demand Charge.....\$0.1642 per CCF*
Commodity Charge.....\$0.1859 per CCF

**Applied to higher of current month consumption, highest monthly consumption in preceding eleven (11) months, or 75% of the highest monthly consumption occurring during the preceding five (5) year (60 months) window. All as adjusted to a 30.4-day equivalent.*

Minimum Bill:

Facilities Charge plus Demand Charge

Sales Tax:

MPW assesses Iowa sales and local option taxes on water bills when applicable.

Late Payment Penalty:

MPW allows customers one late payment each year without penalty. We assess a penalty of 1.5 percent on the total water balance for additional late payments in the same year.
