Facilities Charge:

This charge covers fixed costs that Muscatine Power and Water incurs to service each customer, regardless of usage. These costs include service facilities, meter reading, bill distribution, and payment processing.

Commodity Charge:

The commodity charge is the cost of the water supply that you use – it represents actual consumption. CCF is the measure of water use. One CCF is approximately 750 gallons.

Demand Charge:

A demand charge applies to Industrial I & II customers. The demand charge will be applied to the highest of current month consumption, highest demand in preceding eleven months, or 75% of the highest monthly consumption occurring during the preceding 5-year (60 months) window. All adjusted to 30.4-day equivalent consumption.
